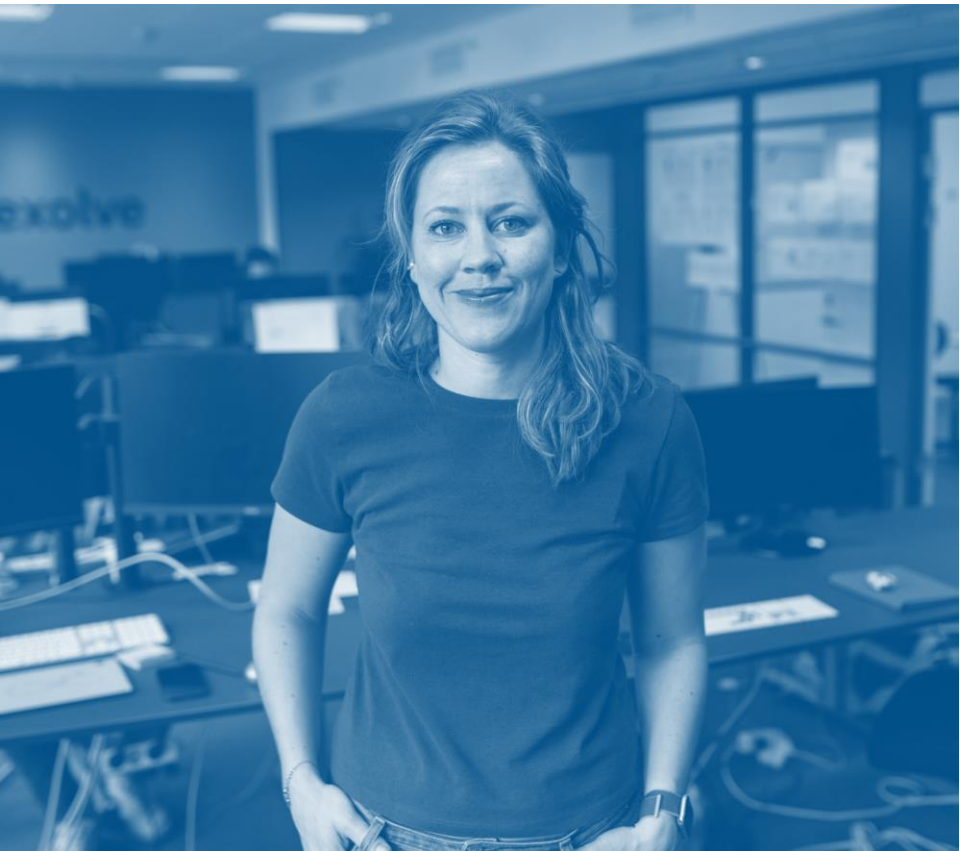

Digitalization – future for lawyers

Will we have a future as lawyers?

Will people ask ChatGPT and the likes for legal advice instead of lawyers?

Merete Nygaard is an Oslo-based lawyer-turned-entrepreneur. She founded Lexolve in 2017, Norway's first disruptor of the B2B legal sector. Since then, she has played a prominent role in driving innovation across the legal industry. Her passion lies in promoting access to justice for all, which has led her to create one of the world's largest legal tech communities and initiate legal hackathons.

Merete is also a strong advocate for breaking the lawyer monopoly in Norway. In addition to her work in the legal sector, she is deeply engaged in creating a solid legal and political foundation for growth companies in Norway and has recently spearheaded a debate on their behalf.

The electronic platform Encrochat - as evidence in criminal cases

Can we allow police to hack encrypted electronic platforms to obtain and use material as evidence?

Why is Encrochat as evidence a problem for legal certainty and defense lawyers throughout Europe?

Is this the start of legalization of mass eavesdropping?

Encrochat is an encrypted communication platform that French police managed to decrypt in 2020. After hacking the system, they were able to eavesdrop 32 477 users in 121 countries - some of them Norwegian. The Norwegian Supreme Court allowed the usage of Encrochat as a evidence in criminal cases in 30th juni 2022, same as in other countries.

Marius Oscar Dietrichson is one of the most famous defence lawyers in Norway and has been working as a lawyer since 2001 for Advokatfirmaet Furuholmen Dietrichson AS. He is admitted to the Supreme Court of Norway. Earlier in his career, he has served as deputy judge at both Oslo District Court and Moss District Court, as well as a police prosecutor between 1996 and 1999.

In addition to this, Dietrichson has held positions as a member of the Board of Directors of the Norwegian Bar Association since 2016, leader of defence group in the Norwegian Bar Association since 2015 and of member of Advisory Board of (European Criminal Board Association) between 2015 – 2019.

He has carried out research in many areas of legal psychology, including face recognition, memory for names, memory and emotions, memory and trauma, and lie detection. He has received a PhD from the University of Nottingham and has since worked at universities in France and at the University of Tromsø. In 2003 he was appointed full professor at the University of Oslo.

He has been an expert witness many times in Norwegian courts, and he is a member of the Norwegian Criminal Cases Review Commission. He teaches legal psychology to law students, psychology students and judges.

What was the background of the climate lawsuit in Norway, the strategy and the legal questions that were highlighted in the case?

What is the legal content and significance of the environmental clause in the Norwegian Constitution?

What impact might the SEA Directive (Directive 2001/42/EC) have on decisions that impact on the environment, as per the judgement from the Norwegian Supreme Court?

The climate lawsuit was pending before Norwegian courts from 2016 until the Supreme Court of Norway in plenary gave its verdict in 2020. The case has been taken up for consideration by the ECHR. Before the ECtHR decides the Norwegian case, it's Grand Chamber will pronounce on three climate cases (Verein KlimaSeniorinnen et al. v. Switzerland, Carême v. France, and Duarte et al. v. Portugal et al.).

Cathrine Hambro was counsel in the so-called climate lawsuit in Norway that was litigated before three bodies, most recently before the Supreme Court of Norway in plenary in 2020. She has worked as a lawyer for a number of years, is a specialist in environmental and resource management law and is admitted to the Supreme Court.

She is now one of two attorney's representing the parties who have brought the Norwegian case to the European Court of Human Rights (ECtHR) in Strasbourg.

An insight from the ECtHRs Grand Chamber hearing in two pending climate cases (Verein KlimaSeniorinnen et al. v. Switzerland and Carême v. France) that took place on 29 March.

What are the Norwegian National Institutions on Human Rights (NIMs) hopes and expectations regarding impacts from the cases already heard by ECtHR on the cases that have not (yet) been heard (Duarte et al. v. Portugal et al. and Greenpeace at. Al vs. Norway)?

The European Network of National Human Rights Institutions (ENNHRI) is one of several third parties in these cases.

Jenny Sandvig is the Director of the Norwegian Institute for Human Rights (NIM).

She has eight years experience as an attorney at the Attorney General's Office. She is admitted to the Supreme Court of Norway.

Sandvig holds an LL.M. from Harvard Law School, specializing in climate law and human rights
